The backup account has 10,003 9921 the Thanksgiving account has 631 30 All we've paid for out of that account so far was an add in shoppers guy to run for two weeks. We still have to pay for our food. No everything's gone up so chances are remains that all last year but sure was his old board rate. They're making this stuffing for us but they're ordering the turkeys and like potatoes like a lot of food for us. So we're gonna get it from a vendor but like one of the vendors we get the large quantities but I didn't get that bill yet. So I don't know how much that's gonna be. And then the golf tournament Council has the same money at 330 1009 2054 Dave we have two sides. Two more slides still to get made the two that were missing. I sent a right after the golf tournament. I set David an email to make those signs for us. And then I never heard back from him and I honestly once said somebody when I pass it along, it's somebody else's responsibility and I don't like Greg the follow up but I followed up and he said, Oh my god, I can't find your email. Now. He says I'm so sorry. That was just this week. So I sent it back over to him. So I don't want to close out the golf tournament account until I have all the expenses paid. And I'm just OCD about that. So once that's the last bill that's out there. And so once that's paid then I'll transfer everything but the \$500 into the backup account. So the big news is that we got a second grant to fund for developments with small business sector over 65 paying the prior federal award was for \$240,000 thereto is you know, and I came back from vacation to fries in my inbox and notice that the Fed has also given us 124,000 To shave for the development of the business plan maintenance plan and curricular programming. So what that means is the way I wrote the grant is I have four organizational partners, teeth being one of them. Connecticut rural, conservation and development, which is an agricultural advocacy group of which I am on the council is a member of large and Eastern Connecticut conservation district to work on the development of this in addition to having input from TDA EDC Thompson AGOA. The concept that I pitched to affairs per se what I've been talking about all along, having a focus on food system and small agricultural startups, not as an exclusive focus, but as the main focus to draw people in because that's where we're situated. We're situated in a rural area. And because those kinds of careers are things that you can access with limited higher education, right. So it's, it's a good fit for our physical region and also our educational profile, what we've got going on. So each of those four organizations has a different expertise to contribute to the development of the facility. Fatigue obviously can hook us up in the long run with a clientele right to potentially take advantage of the program that would be offered in basic business skills or in food system. Business Development, also allowed us to access their professional kitchen the Connecticut rcmd has experience developing things

like agricultural Commons and do outreach to veterans for farmers, young farmers, so to try to pull them in ECCD Eastern Connecticut Conservation District their specific expertise is going to be helping to develop the landscape plan for the adjacent 3.2 acres, which I've targeted as a free food forest public park developed on permaculture principles. I can talk for an hour about that except behind the building that's behind so Riverside Park is a 14 acre parcel 3.2 acres of that abuts the back end of 65 Bay and is currently inaccessible to the public. It's lousy with invasive species. So the long term plans attempt to develop that landscape plan which will clear the invasives replacing with high food value edible native species essentially SFR that would be free food access. Right so my bush blueberry Yeah. So but that's all the planning and then we're gonna say oh in Turkey type of planning and policy group. One of my predecessors as planner for the town of Thompson is George's kowski. He's done a lot of work to develop plans when he used to work for CME engineering. Now he's out on his own so he's going to help me put together the public engagement process because I what I pitched was essentially a year long Charette like we did with the brand new study, like get get the interested people in come in to really you know, meet regularly designed this curriculum so that it meets the actual needs of the community, not just whatever I cook up in my head. Yeah, right, because I can cook stuff up in my head all the time. That doesn't mean it needs community needs. So that's what's being funded. So now we have the architecture engineering funded, we've got the rental funded, we've got the program development funded. There will be one more round of funding that I go after. That's for implementation. To get it off the ground before it becomes self sustaining. But for the next 18 months to two years, that's what we're going to be looking at. So as it ramps up. I'm going to be coming back to back to you guys going, you know who wants to be involved, how you want to be involved, and we'll have to develop a schedule. Now I just got this notification. I haven't seen a grant agreement yet. So I'm sure it'll be a couple of months before we can even get that piece rolling but
