So it becomes a catch 22 And it does break I see this multiple times I've been in real estate since 1983. I started flipping their houses in 83. So I've seen as I said as an 89 course 2007 or so. But we'll get through this one too. You know, I know you guys love to kind of play right now. You guys are working for April that's as far as to what we just go make sure if you guys are looking at listing properties or interested in buying or going to some someone else, make sure that they come see us beforehand. Especially if they're looking at selling and selling your property. Make sure you go see a mortgage loan officer before you sell your property so you shouldn't even buy a property. A lot of people will get an assumption you've been paying this mortgage for 20 years plus they can afford the mortgage. But it was 20 years. You picked up two car loans you sign for your brother in law or cosign if your brother was camper. You're

signing your kids go to college, law school, that kind of stuff. You might not be able to get a mortgage. So if you are looking at selling your property, make sure that you take the time beforehand to go through get pre qualified so that when you do sell your property you can replace because that I have seen I was a realtor for 16 years as well. So I mean I've seen I've seen that happen as far as the loans to zero I say ours is a USDA and that isn't that's no doubt Pam 100% financing. It's a great product for this area, and everywhere around everywhere except for in Eastern Connecticut except for Norwich New London all of Windham county is available for that. FHA loans are three and a half percent down. They're a little more liberal and are easier to qualify for but at the same time they are going to be a little bit more expensive, which is if it's easier, quicker, it's probably going to cost some of the some of the fees and stuff that go with an FHA one or higher and the minimum insurance is going to be higher. When you do VA loans, VA construction loans he was a construction loans FHA construction loans. I even have a loan product where but he isn't really so he's have to buy if you want to build a house by the way and pay off the land the way to your name you use that as a down payment for the for the house. You don't need to do that anymore. I can I have one products, zero down payment, I get you the money for the way and the money for the construction. All one closing and you just pay on all your dues pay on the draw room when you pull out towards the construction to his land to pay that monthly. And then when you finish with the loan converts to a conventional mortgage, so it's a fantastic product as far as the view on VA loans are 100% financing FHA loan exceeds two and a half percent. We also do conventional loans I can do 3% is literally sweeps and down. name to match. Here's a financing to not apply to the property that you want apply. It's everything that I do we do my my pain comes from the bank itself and bank pays me commission, whatever loans that we sell. The bank pays a commission by bringing them putting the buyer together with the bank. That's why we don't take any money from the buyer. Pre qualifications are free. The financial aspects as far as what lawn wood products that's all free, we get it I give advice all day long for free people call me. I'd be happy to talk to anyone to be able to use even if you're gonna go with someone else. You just want to kick back and get another opinion. I'd be happy to look at it. Don't Don't be shy. Not to bash the local banks but the local banks have set programs they have three or four programs or whatever they fit into. And if you don't fit into those three or four programs is I'm sorry we can get you the wrong the person walks away saying he did wrong you can get along okay, you might maybe you can. But you go to a private bank or the local bank. They're gonna have a few programs you the fitness programs that I work with literally hundreds of banks all across the country. And what happens I take all your information and it gets persisted and all the banks will the insurance companies have been on it for mortgage insurance. The banks are always going to go buy your information and your credit scores and all that kind of stuff. But the fact that may just be clear that just because someone finders shuts you down doesn't necessarily mean that you can get along. You need to shop around when you're when everyone's gonna go buy a house. There's an old saying before you buy a house, you buy money, and that's what I do they sell money. I'm assuming that I can still run the Zoom meeting on a screen to show the new documents but what we have received from the permaculture consultant are a couple of 100 pages of his final report in summary, updated full color concept plans and planting schemes. So this this month's workshop from sixth to eighth on the 27th Here we'll be looking at those getting final comp comment on them, but also trying to start to think about the strategies for implementing that piece which is the site designed. In April, May and June we're going to move on to three months of workshops that begin to refine and define the relationship between the future facility for 65 days and the career paths at the high school. And then July August September, which will be the last few months of the public workshop process are the ones that are going to be most relevant to this group because that's where how does the how does the facility actually serve small business what are the workshare office sharing? What kind of team education business skills coursework? Are you interested in? I was talking yesterday with one of my nonprofit partners, Connecticut rural Conservation and Development area for the June workshop. They are going to arrange for three speakers to come in from click and Willimantic probably from an office share facility and also from some of the startup farmers that are CMD has advised because one of the functions we're trying to connect over there's people who aren't interested in agricultural startups. So that should be a particularly interesting one. So today, in June, the human market calendars now we know the day fourth Wednesday of every month, that would be really cool. So if you haven't participated, you don't need to have been to every single one you can drop in month to month. The conversations have been great and that project is really really shaping up very nicely. The priorities are really getting articulated well. And by the time it's all wrapped up, and then I have the final six months to write the master plan. We should have a really good program described which then is my big job is to go out and get more funding to actually open it up. So those are the big things. EDC is going to be interviewing candidates for the marketing campaign for all of the redevelopment work that we're trying to promote on routes 12 131 in here downtown, the zoning regulation improvements subdivision regulation improvements, the kinds of efforts that we're making with the 65 big project to try to generate interest for people who want to actually locate their businesses. Here, more than residences. This is the economic development piece so that campaign will be launching soon as we select a vendor. And any questions, friends.
